This is JBI's policy regarding flight payments and/or reimbursement and is directly from the JBC Handbook:

One return economy airfare each year will be provided from the funds available for distribution to Centres for each Director or proxy to attend the face-to-face COD meeting and preceding convention/colloquia in full. The Joanna Briggs Institute will organise flights for each Centre to avoid delays in reimbursements. Please note that accommodation, per-diem expenses and any additional airfares are the Collaborating Centres responsibility and should be organised by the Collaborating Centre. Registration for the Convention/Colloquia is also the responsibility of the Centre. Please ensure you register as a member for the discount.

For those wishing to book their own flights this is able to be done with JBI paying for the portion of a direct return economy flight. You will need to provide your itinerary along with the attached invoice which should include your bank details, or if wishing to be reimbursed by draft, a full address for this to be sent to (please be aware this method can take up to a month). It is also very important that the full name of the person or institute to be reimbursed appears on the Invoice. JBI will take no responsibility for late reimbursement if Invoices are not filled in correctly.
